ALL MINERALS ON EARTH BELONG TO ALL OF HUMANITY. ALL PEOPLE NATIONS, PER CONTINENT, WILL CONTRIBUTE TO THE COST OF EXTRACTION AND PROCESSING OF ALL THE MINERALS. THIS IS NOT DONE BY A SELECT FEW RICH INDIVIDUALS . ALL MINERALS WILL BE PROCESSED IN CHOSEN CENTRAL PROCESSING OR REFINING UNITS. ALL MINERALS WILL BE DIVIDED EQUITABLY PER CAPITA AMONGST THE PEOPLE NATIONS, PER CONTINENT. THE MINERALS FOUND IN A PARTICULAR NATION BELONG TO ALL NATIONS IN THIS WORLD. WHAT THIS MEANS IS IF THERE ARE A LOT OF MINERALS FOUND IN “NATION”, THEY BELONG TO ALL OF HUMANITY. THIS PARTICULAR NATION NEEDS TO

SHARE THESE PRECIOUS MINERAL RESOURCES WITH OTHER NATIONS THAT DON'T HAVE ANY AVAILABLE NATURAL MINERAL RESOURCES.

ALL PLANTS, TREES AND ANIMALS ON EARTH BELONG TO ALL OF HUMANITY. ALL PEOPLE NATIONS, PER CONTINENT, WILL PROTECT ALL PLANTS, TREES AND ANIMALS, WHICH ARE MAJOR LIFELINES FOR HUMANITY. IN THE LAST 50 YEARS HUMANITY HAS LOST 50% OF ALL ANIMALS. HUMANITY HAS TO MAKE SURE THAT IN THE NEXT 50 YEARS THE REMAINDER OF THE ANIMALS DON'T BECOME EXTINCT. **WCPC WOULD LIKE OUR CHILDREN AND GRANDCHILDREN TO SEE THESE ANIMALS.** ALL PLANTS, TREES AND ANIMALS HAVE TO BE PLACED UNDER PROTECTION BY ALL PEOPLE NATIONS, SET FORTH IN THE UNAA AND IN EVERY NATIONAL CONSTITUTION. REMINDER: PLANTS AND TREES PROVIDE 40%; PLANKTON PROVIDES 60% OF OUR OXYGEN BREATH. THE WORLD (ALL NATIONS) APPLY **SUSTAINABLE** OR **FREE** PRINCIPLES AND PRACTICES ONLY!

No country in this World should be given permission without consultation with the UNAA to cut any of their trees. The trees in any particular country belong to Humanity and nature. Plants and trees contribute 40% of Oxygen to this World. If you cut any trees it will

eventually have an impact on our total Oxygen level. We can't afford to mess with this lifeline. For example if Brazil wants to cut down the rainforest ecosystem it cannot do so without consulting the World or the rest of Humanity. The rainforest trees play an important role in the water regulation as well in the O₂ production. They are considered one of the "lungs" of planet Earth. Besides these important functions, the rainforest ecosystem contains a wealth of botanical information and is also the home of numerous animals, who have the right to have their home. The World needs to protect the animals and their habitat at all cost.

A comprehensive rights, freedoms, duties and responsibilities charter for all human beings (world citizens) in this World

ALL PEOPLE NATIONS, PER CONTINENT, WILL PROTECT ALL HUMAN BEINGS. ALL HUMAN BEINGS HAVE TO BE PLACED UNDER PROTECTION BY THE UNAA OF ALL PEOPLE NATIONS PER CONTINENT. THIS NEEDS TO BE LAID OUT OR EXPRESSED IN EVERY NATIONAL CONSTITUTION.

Humanity (all human beings) has to learn to be good to itself (all human beings). Human beings have to learn to be good to themselves, others (friends, families and neighbors), nature at large (minerals, plants, trees and animals), Humanity at large (all neighbors) and planet Earth at large, which consists of the element earth (food, drink, breath), the mineral water (food, drink, breath)

and the element air (food, drink, breath). Planet Earth is your Home, Backyard, and Hub of life! Planet Earth is your Lifeline!

All citizens of this World should be registered in the World Citizens Registration Centre (WCRC). All human beings will have an identity card with their WCRC number. Each country will have a different entry code, followed by city, village and settlement numbers. The World Citizens Registration Centre has a name, a valid address, valid contact information and general personal information. This would replace all passports.

All Citizens in this World are protected by their respective Continental UNAA and the UNAA as a whole. Each Continental UNAA has a combined military, policing force unit to enforce the human, animal, plant, tree and mineral rights charters for all its people nations. All national police and military armies become the UNAA Humanitarian Aid Centre with peaceful, humanitarian policing soldiers. Each nation contributes 10% of their national police force and military army to the Continental UNAA policing soldier Army. The nations' policing and military Forces should become an integrated national humanitarian UNAA military, policing Force, enforcing the human rights, duties, freedoms and responsibilities of all citizens of a nation's continent and to maintain Law and Order. In an enlightened World there is no need for a military policing force. You are the law.

The human rights charter contains:

The right to have a personal identity (name) that can be changed

The right to live free, just, safe and secure everywhere in the World

The right to have a nationality that can be changed

The right to personal, individual human self-development through strengthening the acceptance and respect for human rights, duties, freedoms and responsibilities while promoting enlightenment or an awakened understanding through awareness and education resulting in friendly, positive, altruistic inter-human, interpersonal relationships

To accept and respect the human rights, duties, freedoms and responsibilities and the personal human development of others and the community at large. Through accepting and respecting the human rights, freedoms and responsibilities of all others allows the right to personal, individual human self-development

The right moral and ethical protection of freedom of thought, opinion, expression (material, intellectual, arts, religion, science, culture etc.) within the **limits** and **restrictions** of the national and international laws whether political, socio-economical, cultural or national, etc..

The freedom of speech comes with appropriate **limits** and **restrictions** laid out by the “Will of the People” consensus legislation and **not a select few individuals** (government, technocrats, corpocrats, financial, royal and noble superelites and elites) who decide what is right or wrong or what they personally agree or not agree with.

The right to have an adequate standard of living concerning the basic sanitary amenities of life or universal minimal (basic) living requirements: food, housing (home, domestic), environment, clothing, medical care, social services, etc.

The right to have privacy; family, home, correspondence, property

The right of social security and protection with honor, dignity and respect

The right to have a universal education; education should be free for all and paid for by a very different ingeniously set up point credit system

The right to have work (labour) and to work under just and favorable circumstances with good wages and pensions, protected by proper unions with the right to strike, picket, organize and demonstrate properly and appropriately according to protected, positive, friendly awareness bringing interventions.

The right to have affordable universal health care (hospital) including pharma care, dental, vision, hearing, long-term, mental health, personal crisis, addiction care centres and transitional houses

The right to have affordable public childcare services

The right for security when unemployment, sick, disabled, widowed, retired, situations beyond control and special care + assistance

The right to marry

The right to have universal (basic) protection (security) of the UNAA and the nation's government

The right to have a universal manufacturers (industrial), retail (commercial), transport and client (consumer) system

ACCEPTANCE AND RESPECT FOR HUMAN, RACIAL, MALE, FEMALE, GENDER AND PAY EQUALITY OF ALL HUMAN BEINGS SET FORTH IN A WORLD CHARTER OF RIGHTS, FREEDOMS AND RESPONSIBILITIES OF ALL CITIZENS IN THIS WORLD OF THE UNAA AND SET FORTH IN EVERY NATIONAL CONSTITUTIONAL LAW. THIS INCLUDES LANGUAGE, RELIGIOUS, CULTURAL, POLITICAL, SOCIO-ECONOMICAL AND NATIONAL EQUALITY.

The true causes of illness and death in some undeveloped and underdeveloped countries in this World are **warring factions, malnutrition** and **starvation**

due to **poverty** and **overcrowding**, **lack of basic sanitation**, **contaminated water supplies**, **pollution** in general, **toxic medicines**, **toxic vaccine campaigns** and **toxic pesticides**, some of which are banned in many other countries. If we eliminated the poverty and overcrowding, which often leads to malnutrition and starvation, improved the basic sanitation, diminished the general pollution, stopped the vaccine campaigns, stopped the toxic spraying, the health of the people in question would automatically improve without any medical intervention. Some transnational corporations and foreign governments are colluding with and paying off local corrupt government leaders to set up shop in these undeveloped and underdeveloped countries for deliberate exploitation. They are extending big loans knowing very well that they cannot be paid back. The loans are mostly given to fill the pockets of corrupt individuals to obtain permission, cooperation and access. This financial scheme allows them to take advantage of the situation. They steal the land and use the healthier people to work on their giant commercial farms and factories. This vicious cycle needs to be stopped. The first World countries, the royal and financial elites need to step up to the plate to help and allow these nations to flourish. They need to become energy independent to be able to kick-start their own economies to develop towards a thriving nation. They need financial help combined with proper education and guidance, not exploitation.

(NOTE 3: revisited and revised original UN citizen rights charter)

The end of racial, human, men, women, male-female (gender) and salary inequality. Equality of all “human beings” in this World means to be a recognized, accepted and respected World citizen; national citizen based on being “human”. By human equality is not meant “equality in gift or talent”, “equality in opportunity” or “equality in outcome”.

The WCPC is not against the LGBTQ2s+ community people. You are a child of Humanity. You are a relevant member of the family of Humanity. You are accepted. The WCPC is against putting the LGBTQ2s+ minority ideology in the face of a majority that is not interested in this ideology whatsoever but is forced through lobbyists and propagandists to accept this unnatural gender ideology, which makes no sense at all. There are only two sexes. You have the freedom to interpret these two sexes the way you want or like or see fit through your own private LGBTQ2s+ outlet. The World doesn't need to see this or have it shoved in their faces. You will be given proper respect, proper protection against bullying, proper guidance, support or therapy when needed.

The Laws concerning sex change procedures and operations need to be sharpened. A sex change procedure and/or operation cannot be allowed before the age of 25 years. By this time most people will have

outgrown this idea and will have reached full or partial maturity or have grown up. They will know themselves and their lives better. They will have some life experiences and some relationships under their belt and know more what they want out of Life. If after the age of 25 years they still want a sex change, they will be allowed to do so with informed consent, proper care, proper guidance and assistance.

We are all equal as human beings equipped with our own unchallengeable, inalienable, natural and learned gifts, talents and skills. We don't have equal opportunity. Some are more fortunate than others in home and business value, ability, strength and intelligence. We do not have equality of outcome. Equality of outcome is practically and pragmatically unachievable. Everyone has to be properly educated and motivated to be the best person they can possibly be. It is important to establish a balance between the individual and the community at large. In order to motivate and stimulate the individuality there has to be a limited difference.

The divide between the bottom and the top needs to be limited or capped. This is referred to as the divide between the top "rich" and the bottom "poor." The divide for example could be 1:10, which means the bottom **guaranteed income is 1** and the **highest top salary earnings are 10**. With a capping system set in place the ultra-rich can no longer occur. In Norway the salary differential between the top and the bottom is

about 1 to 4. In the US it is about 1 to 25. In Brazil it is 1 to 57. Salary capping is necessary to keep the divide between the “rich” and the “poor” from widening more and more and to stop the “ultra-rich” from occurring. Please ultra-rich, share 60 to 80% of your wealth with Humanity. Planet Earth needs you very much.

The guaranteed income is determined by the lowest denominator. The minimum wage salary can be seen as the guaranteed income. If you are an independent adult who is unemployed, sick or retired without pension, you will receive a minimal guaranteed income. This will replace all existing social, health and retirement assistance payment infrastructures. If you are working, you will receive either an amount equal to the minimal guaranteed income or “minimal wages” or an income based on a salary-capped system varying from 1:5 or 1:10 times the minimum guaranteed income for example.

The guaranteed income principle mentioned here should not be confused with the central bank digital money project, which is an underhanded project with the goal of total and absolute control of everything and everyone. This project is based on a digital programmable money system, which runs from your “wallet” on your smartphone. This would replace the present money system. It will have a limited shelf life, adjusted tax rates, conditional pay outs, regional boundaries and other imposed restrictions. It will also be able to collect penalty

payments or withhold (cut-off) money altogether from the account holder. The only purpose or goal of this project, which is orchestrated by the central banks, is total and absolute control. The jobless people in need will be getting a minimal guaranteed income or “new money” to implement this evil system of control. The desperate need will be used as a way to accept this new system. The present health crisis has already created this desperate need, together with a generated destruction that has left many of us living in a destitute, existential crisis. The state, which will be run by the super-elites and elites, will ultimately become the philanthropist. Eventually it will be used to subdue and control humanity. The digital central bank money and the QR code are the tools of this system. If this gets implemented it will mean the END OF WHAT IS LEFT OF OUR DEMOCRACY. More can be read on the subject in Mr. Klaus Schwab’s book of the World Economic Forum called: “Covid-19: The Great Reset”.

This is not what the WCPC means with the implementation of a minimal guaranteed income. There is no power, control, status or hierarchy at its base. It is founded on the principles and practices of a thriving, prosperous and enlightened Humanity. The other reason is the evolution of progression or “digitalization” and “modernization” through the replacement of advanced technologies and artificial intelligence, which

necessitates the need for a guaranteed minimal income because of actual job losses.

An ANTI-DISCRIMINATION Law set forth in a world charter of rights, freedoms and responsibilities of all citizens in this World of the UNAA and set forth in every national constitutional law recognized, accepted and honoured by all peoples and all people nation governments immediately.

The race, human, man, woman and gender equalization in this World should not be limited. What this means is that there should be no difference between one race to another, one human being to another, one man to another, one woman to another and one gender to the other. All human beings in this World are the same or equal on the bases of being human. In essence there are no races. There are only human beings. The race theory only goes skin deep. If one were to remove the skin of every person there wouldn't be any differentiation. All human beings would look the same. The color of blood is red for everyone. **The souls who occupy human bodies are either female or male. All souls are the same.**

The salary equalization in this World should be limited. What this means is that there should be limited differences between one nation to another. As a human being the difference of the "standard of living" should be capped by a minimal 1 limit and a maximal 10 limit. What this means is that the guaranteed minimum

income is considered the 1 limit and the maximal allowable income, earnable or hereditary, is considered the 10 x 1 limit. The ratio numbers and amounts may vary per people nation. As a people nation in the World the difference of the "standard of living" should be capped by a minimal 1 limit and a maximal 10 limit. What this means is that the lowest "standard of living" income of a nation is considered the 1 limit and the highest "standard of living" income of a nation is considered the 10 x 1 limit. In an enlightened World this will all equalize over time, which means that all nations would be completely equal.

The salary equalization of genders in this World should be applied everywhere in this World. What this means is that there should be no differences in a nation and limited differences between one nation to another, depending on the national circumstances and situation. The salary equalization for women for the same education, work, skill, gift or talent etc. goes without saying.

The gross national product (GNP) equalization of all people nations in this World should be limited. The difference is capped by a minimal 1 limit and a maximal 10 limit. What this means is that the lowest GNP or the lowest people nation's income, including foreign investments, divided by the per capita population or population unit, is considered the 1 limit and the highest GNP or the highest people's nation income, including

foreign investments, divided by the per capita population or population unit is considered the 10 x 1 limit. In more advanced civilisations the difference between the “high” haves and the “low” have-nots becomes minimal or equal.

A 100% HUMAN, RACIAL, MEN, WOMEN AND PAY EQUALITY IS ABSOLUTELY NECESSARY WITH FULL ACCEPTANCE AND RESPECT SET FORTH IN THE UNAA AND EVERY NATIONAL CONSTITUTION IMMEDIATELY

A 100% GENDER OR MALE AND FEMALE EQUALITY IS ABSOLUTELY NECESSARY WITH FULL ACCEPTANCE AND RESPECT SET FORTH IN THE UNAA AND EVERY NATIONAL CONSTITUTION IMMEDIATELY

The inequality between men and women is one of the main hindrances for human development. Over 40% of the total employment in this World is occupied or held by women. Nearly 30% of management positions in this World are occupied or held by women.

How: It is time that all governments in the world recognize, accept and legalize being human. It is time that all governments in the World recognize, accept and legalize that all human beings from all nations and from all races, all men, all women and both genders are equal in the sense of being human. There should be a World recognized anti-discrimination law. Education is needed! This is where it starts! Male and female equality also needs to be established in religion.

How: It is time that all governments in the World recognize, accept and legalize that all women from all nations and from all races are equal to all men from all nations and all races. Education is needed! This is where it starts! The WCPC Family is asking for all men and all women in all nations to become a member and let our voices be heard all over the World, all people nations and all governments and demand 100% human and racial equality and 100% male and female equality! This World is in need of a proper human charter of rights, freedoms, duties and responsibilities for all humans to follow set forth in the UNAA and all national constitutions of all people nations.

To be free, just, safe, secure and to have an open society are extremely important values. Many countries in this World don't get to experience this because of authoritarian regimes. The countries that have more openness and personal freedom don't want this to be replaced by restraints and having a more closed society due to excessive government interference and control. We don't need more government. We just need the right amount of government. Freedom automatically comes already with a normal set of commonsensical restrictions and responsibilities coming out of Law and Order (rules and regulations).

A comprehensive rights, freedoms, duties and responsibilities charter for all people nations in this World

THE EQUALITY OF ALL PEOPLE NATIONS IS SET FORTH IN A WORLD CHARTER OF RIGHTS, FREEDOMS, DUTIES AND RESPONSIBILITIES FOR ALL PEOPLE NATIONS IN THIS WORLD UNDER THE UNAA AND SET FORTH IN EVERY NATIONAL CONSTITUTIONAL LAW OF ALL PEOPLE NATIONS

Each country (nation) has to act within the consensus limits laid out within the charter.

The equality of all people nations is not limited. What this means is that there is in principle and in practice no difference between one nation to another. The only differences are the size, population and development.

The equalization of all nations is financed by all the governments, noble, royal and financial elites, superelites and “absolute rulers”. The equalization process is aided by proper forgiveness of all national debts and facilitated by building a new, proper national business, financial, legal and governmental infrastructure.

In this World there are a handful of superrich rentier capitalist superelites who own 50+% of this World’s total wealth. The Earth’s richest 1% own as much as 60+% of this World’s total wealth. The Earth’s richest 0,001% own as much as 50+% of this Worlds total wealth. If we don’t

stop them, they will come to own the whole wide World as we know it.

Some of the hallmarks of enlightenment living and governing are to share the power and control, share the wealth, have human and racial equality, have male and female equality and have a shared balance between individualism and communalism. Humanity does not live enlightened!

The globalist oligarch capitalists earn huge amounts of monies or securities gained from monopolized economic practices and access to any kind of property (physical, financial, intellectual, etc.) without contributing to society. There are huge amounts of unused monies and securities gaining interests for the globalist capitalists doing nothing else. These monies can be used to turn this Earth around. Some financial and royal capitalistic elites do share their wealth partially. All people nation governments set forth in law the end of being super-rich through the application of a commonsensical bottom and top-capped “salary” or “income” scaled system.

A salary capped system of remuneration and a guaranteed basic minimal income system are enlightened ideals.

The entire system needs to be replaced by a **not-for-profit form of capitalism** or sharing of wealth, which is the way to go. This refers to a socially responsible politico-socioeconomic philosophy and goes a step

further than conscious capitalism. The premise behind this is that businesses should operate morally and ethically while they pursue profits for the personal and common good. This means that they are serving all stakeholders involved including themselves, their employees (staff), client base, society, the environment, Humanity and planet Earth, which is their Home, Backyard, Hub of Life and Lifeline (bread, water and breath) and not just their management teams and shareholders. This idea is created by the World Centre for Positive Change Ltd. A not-for-profit approach will automatically set in place a different mindset validating, endorsing the process of sharing the wealth. This doesn't mean that hard work shouldn't be paid off. The difference is that there is a limit to what you can earn. The not-for-profit or shared capitalism model is coupled with the "enough is enough" philosophy.

A message for the rich and super-rich: please share 60-80% of your monies with Humanity, nature and planet Earth. We need the help from all the governments, elites, super-elites, "absolute rulers" and collaboration of all the people in this World to turn planet Earth around or do a complete haulover and makeover. Some countries have started this process already.

The present super-rich "absolute rulers", super-elites, elites and all the "rich" first (developed) world people nation governments should help, facilitate, equalize, develop the "poor" second (underdeveloped) and third

(undeveloped) world people nations without question. The sharing of the wealth with the undeveloped and underdeveloped second and third world people nations in this World will allow them to become energy independent and start building their economy from the roots up. You first have to build the infrastructure to sustain the economy.

The WCPC will contribute 30-40% to Project Planet Earth© through donations, memberships and sales of books and paraphernalia to facilitate the maintenance of Earth's sustenance, which sustains all of life.

The present "richer" developed first world people nations and the "poorer" undeveloped and underdeveloped second and third world people nations need to limit the divide between the "richer" and the "poorer" people nations in this World through proper forgiveness of national debts, sharing of aid, sharing of knowledge education, personal and national motivational empowerment, sharing of wealth, sharing of economies and sharing of resources.

It is high-time that the royal houses in every country are abolished and that all related royal and noble functions are abdicated. In an enlightened World there are neither ruling families nor nobility (no class system). *This is an extremely important developmental step for Humanity to take towards human enlightenment.* All throughout human history this

World has been ruled by certain families either noble (royal) or common (influential, cultural, spiritual, religious, financial etc.). To break from this particular long-standing human condition will properly propel Humanity towards the road towards enlightenment (Ego-no more).

Through the process of limited equalization of all people nations in this World, overpopulation can be addressed properly. It has shown that first world people nations have a natural decline in population. The amount of children per family is low. The second and third world people nations show overpopulation because of religious and cultural beliefsystems, high birth mortality rates and the family nucleus is still considered to be the economical unit for survival. The amount of children per family is high. There is also a great shortage of natural and synthetic birth control methods, which also contributes to the problem. The process of limited equalization of the second and third world people nations, which will bring along a better standard of living, will have a natural decline in population over time.

Overpopulation is considered a problem in this World even though we don't really have any idea how many people the Earth and nature can sustain. If the whole World lived in the same density as the city of Paris, France, all of us could be able to live in the state of Montana. That's not exactly overpopulation. Only two percent of the World is build-up with roads, bridges,

cities, towns, villages and settlements. That's not exactly overpopulation. Who asks about and who decides over the question of overpopulation? Who gains? Who loses?

The people or “bosses” who run this Earth ship preside or act on overpopulation. They ultimately decide who is allowed to live or not, to control the population on planet Earth. This shouldn't be entertained at all by anyone, any group, organization or government. This is absolutely and completely absurd and dangerously diabolical.

A constant increase of the human species in quantity and quality is possible if it is done properly. Lyndon H. LaRouche, Jr talks about it at length in his book “There Are No Limits to Growth”.

If Humanity worked together on all fronts to maintain (not waste) Earth's sustenance, which sustains all of life, we would be well within the capacity limit. There would be no overpopulation and no shortages of resources.

Addressing and controlling the total World population isn't that important. Local overpopulation due to socioeconomics is more of a concern. The existing economies do have a limit. They might not be able to handle the amount of people participating in the economy.

We could adopt the balancing act of incoming births and outgoing deaths through granted birth certificates. This needs to be properly thought out and discussed publicly to figure out exactly how this is going to be applied. To obtain a birth certificate, you also have to be educated on “how to parent”, which is extremely important as well as “how to have a good relationship with yourself and others” as well as undergo a psychological evaluation to see if you are fit to become a parent. These courses should be taught in the primary as well as secondary school systems. We should be taught properly about what we are getting ourselves into to have and to rear children. To be fit to be a parent is a prerequisite to obtain a birth certificate. For those who aren’t fit to be a parent and do wish to have children, courses on “how to parent” as well as psychological counselling and support to achieve their goal will be offered. For those who aren’t fit to become a parent and really don’t want any children but have one anyways, proper adoption principles and practices should be set in place. Abortion should be minimized and used only in exceptional circumstances agreed upon by democratic consensus. The population control in industrialized countries should be set at maximal 3 “incoming” children per family in balance with “outgoing” departed.

Limited equalization means that there is a minimal and a maximal “standard of life” or average national income and gross natural product. The gross national product is

the total value of all goods and services produced within a people nation in a year, including net income from investments in other countries. The “standard of life” or average national income is the gross national product divided by the total population or population unit. The minimal wage should be the guaranteed basic minimal income for all the peoples in a people nation.

The process of limited equalization will have a necessary transitioning period. The undeveloped or underdeveloped nation in need of equalization, will make conscious, deliberate and educated choice decisions to develop towards an enlightened, developed nation with the help of all nations (education, expert advise, financial assistance, forgiveness of debt, administration and direction). Take as long as it takes to fulfill the process of limited equalization. Humanity is going to be here on planet Earth for a long time. Take as long as it takes to negotiate willingly, beautifully, peacefully, truthfully, trustfully, logically, commonsensically, diplomatically, no nonsensically, uncomplicatedly, directly and well (good)!

A comprehensive rights, freedoms, duties and responsibilities charter for all religions and religious peoples in this World

The end of the disintegration (schism) of religion and science.

There shouldn't be any judgment against those who believe or who don't believe in a "God". There are many "Gods" in the name of religions. The main motto in your life should be to be a good person, who chooses to live consciously and enlightened.

It is important to remember who we are. It is important to remember that we are human beings on this beautiful blue planet Earth regardless of our race, nation, crede, religion, culture, socioeconomical political conviction etc. We need to come together as **human beings** to unite, to find strength in numbers regardless of our race, nation, crede, religion, culture, socioeconomical political conviction etc. We need to come together to build a network of people we can trust and rely on. This is what is truly important. To be human is the common denominator. This is what unites all of us.

Many people have died in the name of religion. Estimates run at least between 30 to 40 million people in the last 1000 years. This doesn't make religious people look very good.

For many of us it is quite difficult to understand for example how a religious ISIS group works for example and why they believe they need to kill anyone who is not of their religion. To understand what is going on you only need to look at our history. This is just another war in our ongoing belief system that my "God" is better than your "God" or to believe in a "God" is better than not

believing in a "God". These particular beliefs have been part of the Jewish, Christian, Muslim, Hindi and Buddhist religions etc. Each of these religions has had major waves of fundamentalist radicalism and have killed many people who didn't believe what they believed and still do to this day.

Samuel 15:3, "Now go and smite Amalek, and utterly destroy all they have, and spare them not; but slay both man and woman, infant and suckling, ox and sheep, camel and ass." God orders Saul to kill all men, women, and children of the Amalekites because of their parents' alleged sins. "My God is better than your God."

The Bible has many stories of these killings. Just take a look at the last 1,000 years. The first wave of killings was in the time of the Crusades in the eastern Mediterranean or "Holy Lands". There were seven major Crusades and a number of minor ones between 1096-1291, which murdered an estimated 3 million people. "My God is better than your God."

The Inquisition (1250-1834) was the judicial system of the Roman Catholic Church used to combat heresy. It was used all throughout Europe but particularly in Spain and Portugal. It was used to convert Jews and Muslims to Catholicism. The secretary to the Inquisition in Madrid from 1790-1792, estimated that Spain alone condemned 3 million people, with an estimated 300,000 burned at the stake. The witch trials were also part of the

Inquisition, which claimed an estimated 50,000 people in the name of God. Galileo also got caught up in the Inquisition. "My God is better than your God."

The French Wars of Religion (1562-98), which is the period of civil infighting between French Catholics and Protestant Huguenots. Between 3 and 11 million people were killed as a result of war, famine and disease. "My God is better than your God."

The Thirty Years War (1618-48) fought between Protestants and Catholics in Central Europe killed an estimated 2 million to 4 million people. "My God is better than your God."

The Ottoman Empire (Muslim) conducted a policy of genocide or "ethnic cleansing" on the Christian population living within its extensive territory. The Sultan, Abdul Hamid (1894-1923) ordered the killing of 1.8 million Greek Christians, 1.8 million Armenian Christians and 100,000 Syrian Christians, which is a total of 4 million Christians killed by the Ottoman Empire. This ended with the start of WWI. "My God is better than your God."

The last major religious war was World War II, the Holocaust 1941-45, when 8.4 million Jews were killed, including one million Jewish children. Hitler said, "I believe that I am in accordance with the will of the almighty creator by defending myself against the Jews. I am fighting for the Lord. I would like to thank providence

and the almighty for choosing me of all people.” “My God is better than your God.”

The Second Sudanese Civil War was fought between 1983-2005. The conflict began when the Muslim central government imposed sharia law on the Christian south. This war killed between 1-2 million people with 4 million displaced. “My God is better than your God.”

Since 2001, the Afghanistan War has killed an estimated 585,000 people and in the Iraq War 450,000 people as a result of the conflict. President Bush called these wars “The War on Terrorism” but it is part of the ongoing war of Christians vs. Muslims. This war started against the Taliban has now turned into the war against ISIS (Islamic State) and has expanded into Syria and Yemen. “My God is better than your God.”

There are smaller religious wars that could be included, Israeli-Palestinian conflict, Northern Ireland, Yugoslav Wars, Rwanda genocide, India-Pakistan, Congo, Tibet, and civil war in Sudan. These are wars fought in the modern era, the list could go on and on. “My God is better than your God.”

In the last thousand years about 40 million people have died in the name of religion. This doesn't look good for people believing in a God.

Religiously justified violence is first and foremost a problem of people adhering to "sacred texts" and isn't

necessarily a problem of misinterpretation. We hear "God Bless America," why not "God Bless This World." Is God on our side or on your side if we both believe in a God? Does God have a side or a religion? Gandhi said, "God has no religion." Maybe that's the place we need to start. All religions in essence need to accept One God or One Supreme Being. There should be no judgment. This would be a very big leap towards human enlightenment, which has no place for divisive religions. In human enlightenment and soul consciousness there are no religions. "God" is the Universe; "God" is You. This is your journey as an evolving soul. Human enlightenment and soul consciousness will bring forth body-soul transformation to make place for the soul reality consciousness or a soul planet whereby souls live amongst Humanity and nature on Earth.

It shouldn't make any difference whether you believe or don't believe in a God. You can be a good person whether you do or don't. What is often forgotten is the fact that only 51% of the people believe in a God. The rest either doesn't or is undecided.

Religion is an extremely important as well as sensitive subject. How a religion in general as well as the religious people within a religion in particular should behave, is of utmost significance. This religious charter agreement should be reached by consensus between all religions and religious peoples.

The equality of all religions and religious peoples within a religion should be set forth in a world charter of rights, freedoms, duties and responsibilities for all religions and religious peoples in this World under the UNAA and in every national constitutional law.

The recognition, acceptance and respect of One Supreme Being ("GOD") is set forth in a World charter of rights, freedoms, duties and responsibilities for all religions and religious peoples in this World under the UNAA and in every national constitutional law.

All religions should oppose and speak out as a united front against all acts of violence of religious (or any) extremism, fundamentalism or radicalism.

A religion should oppose and speak out as a united religion against its own violent religious (or any) extremist, fundamentalist or radicalist members, factions, groups or organizations.

We wish for all religious non-violent, non-aggressive, peace-loving peoples who belong to or are associated with individuals, groups, organizations or nations that commit heinous acts of violent aggression against Humanity, to stand up and **speak out** against these acts **from within the religion**. This violent aggression is unacceptable. We firmly believe that these systems can only change from within. If a particular religious belief system resists and rebels from within through strength in numbers, there will be a good chance for change. If

other religious belief systems tell a particular system what to do or not to do, there will be great resistance and rebelliousness, which could give rise to religious strife or possibly war.

THE POWER OF BEING AND DOING GOOD: The World Centre for Positive Change would like to facilitate a revolution of “applied goodness” or “to be and do good” to bridge the gaps or “lack of relationships” or “lack of friendships” i.e. brother and sisterhood of Humanity between all peoples of all nations around the World. Be good to yourself (human), others (family, friends and neighbors), nature (minerals, plants, trees and animals), Humanity (all humans) and Planet Earth (earth, water and air) giving us our daily bread, drink and breath! With “applied goodness” great things can happen in this World. **A positive change in our behavior and attitude is all what is needed in essence.**

There are many wars and much strife on Earth, give and take a few. A lot of these wars and strife are driven by manipulative religious, idolatrous, monetary, hierarchical egoic (power and control) ideologies.

Sciences and Religion need to be integrated through education and find peace with each other. All religions need to accept and respect One God (One Supreme Being) for all religions through proper education. (Allah = Brahma = Consciousness = Elyon = Jehovah = **Universe** = Yahweh etc.) There are 108 names for “God” on planet

Earth. This integration will help to get rid of or put an end to all the religious strife in the world. This will help to put the boundaries on religious attitudes and behaviors in the world. This is another very important developmental step for Humanity towards enlightenment.

The state should be impartial, neutral, non-biased, non-religious, non-political, non-prejudicial, non-partisan, non-denominational etc., which means that you cannot have a political party system because political parties are by definition or by default partial, extreme left, left, centre, right and extreme right, biased, religious, political, prejudicial, partisan, denominational etc. The separation of politics and state is necessary and should be set forth in every

national constitution in this World, respected and accepted by every nation. The separation of political religious and political general parties from all state affairs is an important developmental step towards human enlightenment.

For example: you have a nation, which is predominantly protestant and it so happens that in the election the Catholic Party got the highest vote and becomes a ruling Catholic Party over a predominantly protestant nation. The Catholic Party doesn't represent the nation; it represents a minority of catholic religion minded people. For example: the Conservative Party got in on a 40% turnout vote. The Conservative Party doesn't represent the nation; it represents a minority of conservative minded people. For example: the Marijuana Party got the highest vote and becomes a ruling, regulating Marijuana Party over a predominant non-marijuana oriented nation. The Marijuana Party doesn't represent the nation; it represents a minority of marijuana minded people. For example: the Republican Party got the highest vote and becomes a ruling, regulating Republican Party over a predominant non-republican oriented nation. The Republican Party doesn't represent the nation; it represents a minority of republican minded people. In the US the republicans and democrats on the whole represent half of the people nation. The state or nation is not represented by any party. All parties are or represent splinter groupings of a nation's society. The

state or nation is the Party. The ideal state or nation is the ideal to reach. Whether you have 2 parties (US), 12 parties (Netherlands), 13 parties (France), 36 parties (Italy) or over 100 parties (Greece) makes no difference. The parties do not represent the nation. The parties only represent what they stand for and believe in. You could therefore have 1000+ parties in the government standing for what they believe is (their) right. This is not representing the common good.

There shouldn't be a political party driven system anywhere in this World. Political parties are ego-driven, self-interested machines.
